Orientation

Faculty and staff attended a DEI workshop presented by <u>Mindbridge Center</u> as part of an in-service day. This training focused on the neuroscience behind the biases and assumptions that occur when we're trying to process a lot of information quickly and how to interrupt them.

During the new student orientation, Professor Sara Cressey and 3L Aysha Vear led a discussion of the "From Safe Spaces to Brave Spaces" article, as well as guidelines for engagement that the 1L class would like to use.

New students also participated in an "All That We Are" exercise in which students were asked to move to a designated space in the room if they belonged to a certain group. As different types of identities and experiences were listed for the groups, students had a chance to see where they shared similarities and differences with their new classmates.

The law school's newest student organization, the Native American Law Society (NALSA), celebrated the start of the school year with a gorgeous fall evening. Co-chairs Holly Fain (3L) and Cheyenne Acree (3L) hosted the grassroots event with support from the Multicultural Law Society.

It was a wonderful night of community building and learning with a special outdoor screening. The show began with a pre-show entitled "Conversation with Native Americans on Race," which was followed by a screening of the documentary "Warrior Lawyers." Guests enjoyed charcuterie, smoked meats, and treats provided by Two Fat Cats Bakery and Standard Baking Company. NALSA hosted a virtual and in-person raffle, with proceeds to provide support for its professional, educational, and community activities. All raffle items were sourced from Native-owned businesses and curated toward celebrating and embracing Native culture. NALSA raised over \$400 for their efforts.

The organization's mission is to increase the Native American Law student population, to provide greater visibility to indigenous legal issues that affect Native communities, and to better leverage relationships forged between the law school, the legal community, and Native populations state-wide.


